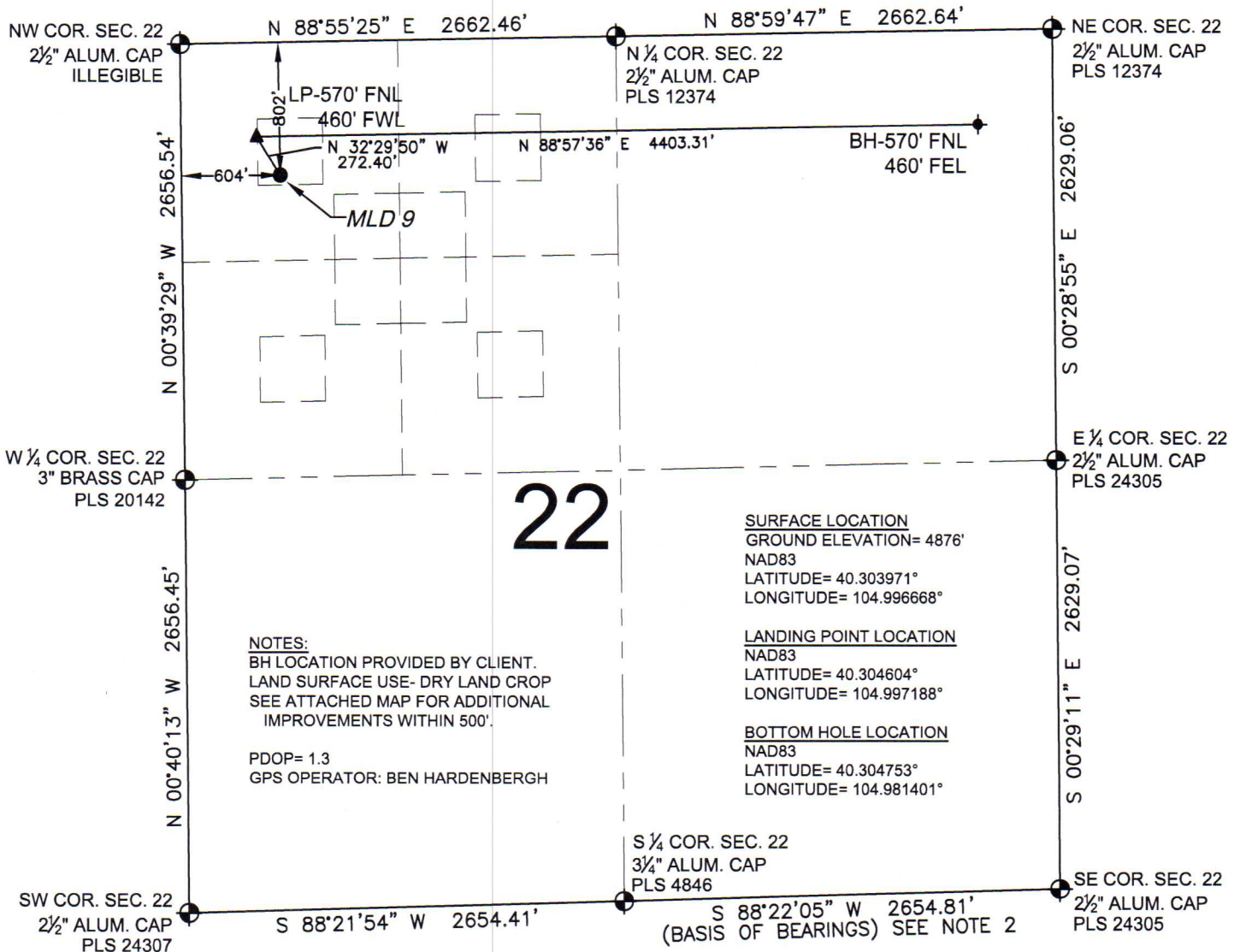


WELL LOCATION CERTIFICATE: MLD 9

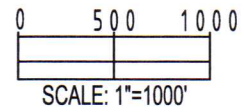
- ⊙ = EXISTING MONUMENT
