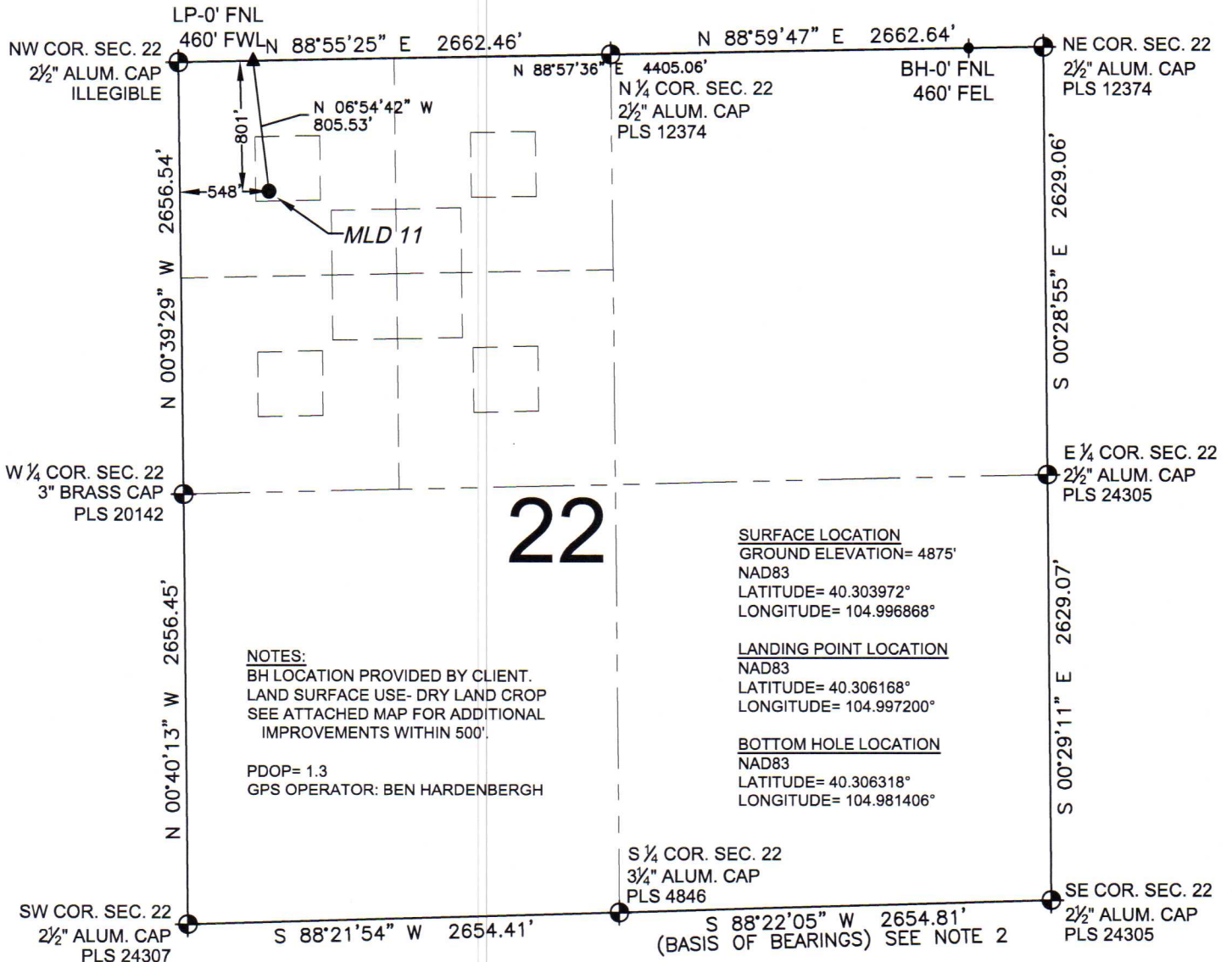


WELL LOCATION CERTIFICATE: MLD 11

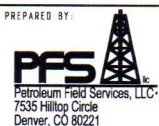
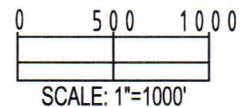
- ⊕ = EXISTING MONUMENT ▲ = LANDING POINT
