#### COMMENTS:

The conductor was preset on the subject well on 10/20/14. Operations were suspended and the well was eventually removed from our future drilling plans.

The conductor was plugged on June 29, 2017 as follows:

1. Locate and expose conductor, remove 8' cellar ring and cut conductor 5' below ground level.
2. RIH with 200' tape locate EOC @ 117' (5' water).
3. Load hole with approx. 9.5 yards 1 1/2" or less road base to 15' of surface.
4. Pumped 15' cement plug with 34 sks (6.8 bbls) of 15.8# 1.15 Cu/ft/sk Class G cement.
5. Welded on permanent steel plate with legal description.
6. Back filled hole to ground level.
