 Mike identified two 500 bbl tanks on 696-18A location that needed containment. In lieu of adding containment, Marathon removed the tanks referred to as "frac" tanks that were used for water storage. Marathon has completed work to de-ice the two tanks and remove them from the pad to the Latham Laydown yard. Demobilization confirmed at 6:25 pm MST 1/16/15.
