Inspection Doc. #682400968 indicated crop at location was not reflective of the reference area as crop on the disturbance area (~20 inches) appeared stunted when compared to the reference area (~50 inches). Inspection required operator to perform additional reclamation. Crop growth over the disturbance area appears to have improved, however crop growth still appears to be stunted (~48 inches) when compared to crop on the reference area (~72 inches). This concern is being forwarded to Weld County Reclamation Specialist Chris Binschus.
