Comment: Inspection Doc. #682400972 identified concerns with equipent/facilities remaining at the battery location. Equipment and facilities have been removed, however battery location does not meet reclamation requirements or standards; Battery location remains heavily compacted. Unable to find perennial crop vegetation establishing at the battery location (reference area alfalfa), it does not appear that battery location had been re-seeded with a perennial seed mix per the COA from sundry doc. #401101441.

Corrective Action:	Perform reclamation including, but not limited to compaction alleviation per 1000 series reclamation rules, and per sundry doc. #401101441, and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 8/15/2017. See "COGCC Comments" for additional CA and CA dates regarding the well location.	Date	08/15/2017

Comment	User	Date
Operator comments in sundry doc. #401101441 stated that all disturbed areas will be cross ripped to alleviate compaction. A COA attached to this sundry required that the operator will use a seed mixture approved by the surface owner when revegetating the location. Corrective actions and conditions of approval have not been addressed as compaction alleviation has not been sufficiently performed and the battery location has no been re-seeded/revegetated.	trujilloam	07/11/2017
COMMENT Well location does not meet reclamation regulations; insufficient vegetative cover. Transects were conducted indicating vegetation is not reflective to that of the reference area. CORRECTIVE ACTION To allow time for Noble to collaborate with the surface owner and determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production, and to allow time for Noble to identify the issues hindering crop growth, all required reclamation activities shall be completed no later than September 15th, 2017. Once completed, Noble shall submit a resolution documenting what work had been conducted.	trujilloam	07/11/2017
