Comment: This location does not meet reclamation requirements. Location has not been returned to crop, or stabilized with total perennial, non-invasive uniform plant cover. Vegetation over location predominantly undesirable weedy plant species such as kochia, Russian Thistle and Canada horseweed, as well as Colorado State listed noxious weeds such as Musk thistle and bind weed.

Corrective Action:	Perform reclamation; remove and manage weeds. Collaborate with the surface owner to determine a seed mixture to be used to stabilize the location with total perennial, non-invasive uniform plant cover. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. To allow for a fall seeding, revegetation activities shall be complete no later than 11/15/2017.	Date	11/15/2017
