<p>Reclamation in process. Subsequent form 6 #401314861 currently in process and pending approval. Form 6 states well was plugged 05/25/2017. Facilities at the well and tank battery have been removed. Meter shed north of the well still remains. Reclamation rule 1004.a requires that all equipment be removed within 3 months of plugging the associated facility. Equipment will need to be removed by 8/25/2017. Well location, battery location and access road still requiring reclamation including (but not limited to) road base removal, compaction alleviation, re-contouring, re-grading and re-vegetating. Reclamation rule 1004.a requires all such reclamation work be completed within 12 months on non-crop land after plugging a well. Reclamation and re-vegetation activities shall be complete no later than 5/25/2018. Ensure that a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS is used. Ensure erosion controls are implemented to stabilize the seeded soil and location(s), and continue to monitor and manage this site until Final Reclamation has passed.</p>	trujilloam	07/12/2017
