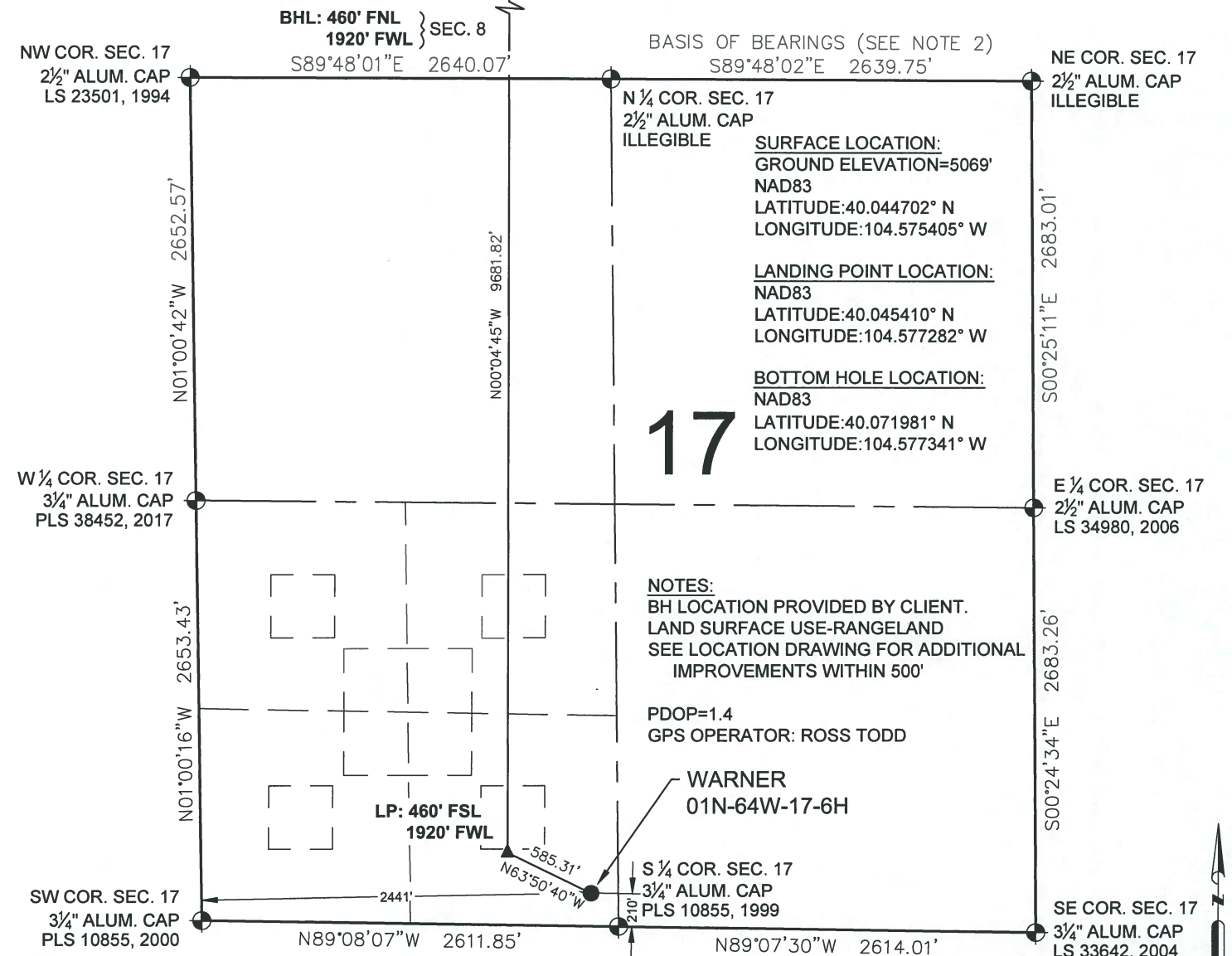


# WARNER 01N-64W-17-6H WELL LOCATION CERTIFICATE

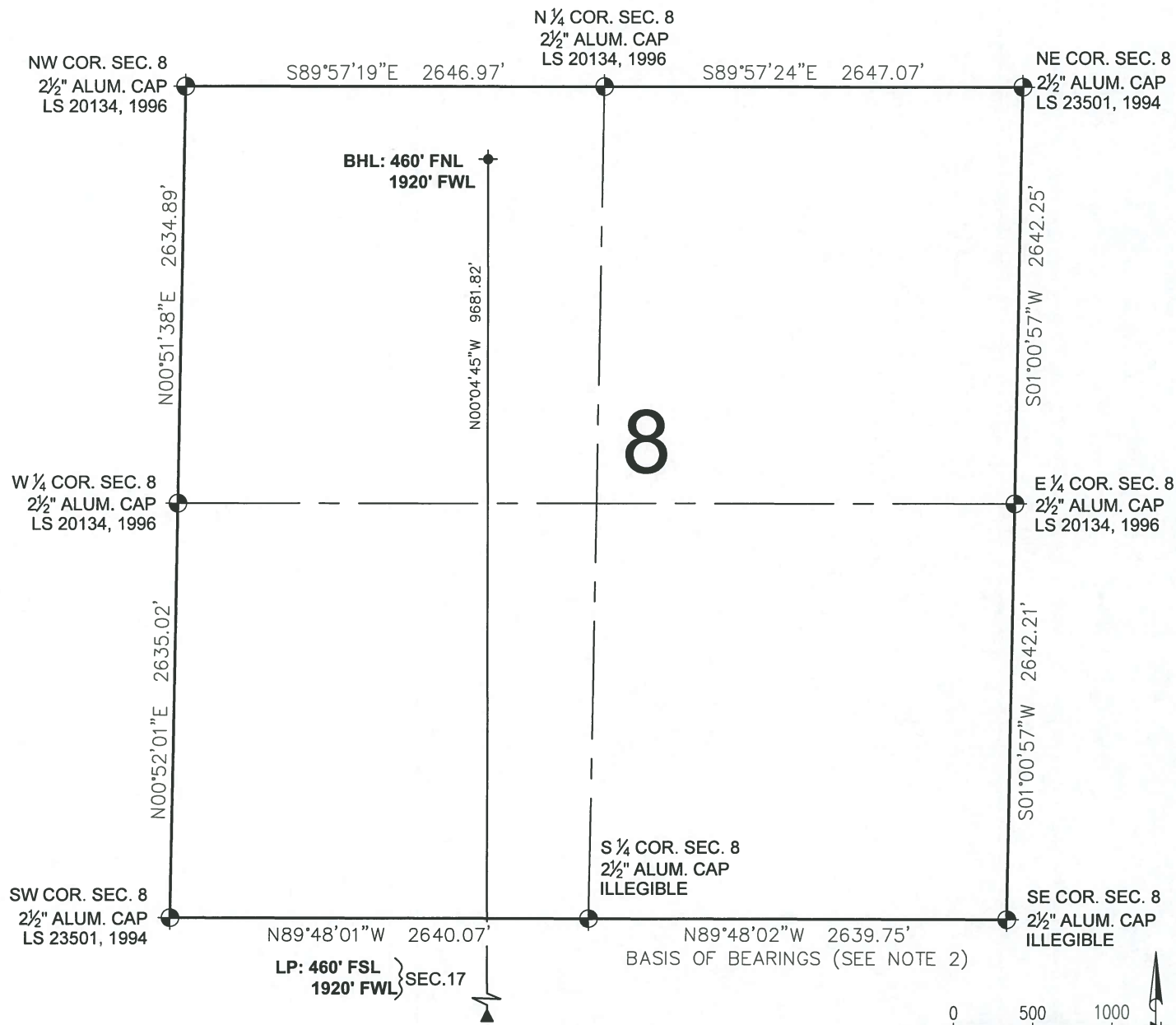
