<p>Comment: Stormwater controls currently installed in the northern diversion, northeastern corner, and western diversion of the well pad, as well as the access road culvert near the entrance to the well pad, are insufficient and largely failed. Exposed soils on the cut-slopes are not sufficiently stabilized. See attached photos.</p> <p>Corrective Action: Stormwater erosion needs to be controlled within the project area via permanent stormwater controls that will have a long term ability to stabilize sedimentation, de-energize flows in diversions and culverts, and filter sediments from stormwater leaving the project area. This includes revegetation of the well pad cut-slopes to stabilize soils. Revegetation should be conducted at the appropriate time but no later than November 1, 2017.</p>						Date: 08/28/2017
