Nearest Wellbore complete in the same formation: French Lake 3-62-6 #1H, API 05-123-33453.

BCEOC only recently rescinded this APD as required by an adjacent permit application. Recent surface owner negotiations have stalled and BCEOC would like to get this permitted location and the associated well reinstated as soon as possible as a back up plan to the current permitted location and well. If BCEOC cannot negotiate access to the active location prior to the pending August lease expiration date, BCEOC will have no choice but to drill this location in order to maintain the lease.

BCEOC requests approval as soon as possible. Without expedited approval, BCEOC would not be able to begin drilling prior to the lease expiration date, which could result in lease cancelation and a significant loss of investment.
