Jason-

Surface owner approval is required to expand and treat the materials on location. Additionally, your plan does not describe how you will be adequately treating and remediating the materials. It merely states that the *"Dirt inside bermed area will be rototilled every 14 days."* How are you going to determine the effectiveness of treatment? (this was discussed during the June 1, 2017 meeting). I have pushed the F27 back to Draft.

I see two options:

1. By July 21, 2017 resubmit address all of what we discussed during the June meeting in how Diversified Energy will remediate the material. It is strongly suggested that you retain the services of an environmental professional or environmental consulting firm.
2. Haul the materials off site to an approved facility.

By August 4, 2017, provide additional financial assurance in the amount of \$20,000.00.
