We are working with the COGCC to expedite approval of a drilling pad and APD that was previously approved and recently rescinded. The State Longhorn 41-12 location (449415) and corresponding State Longhorn V41-12-11XRLNB (05-123-44303) were refiled this morning. We can discuss the history via phone when you have a chance. The COGCC is aware of the entire process as they have been helping along the way. If we are not able to drill the well currently under negotiation or the above well we will be subject to lease cancelation.

I just refiled the above OGLA and APD with the COGCC for expedited approval. As part of this process I need to obtain authorization to waive the 20 Day Statutory Notice. We have this authorization from the surface owner (SLB), but the COGCC also requested that we obtain authorization from Weld County.

Can you please respond to this email authorizing us to move forward without the 20 day statutory notice? If you provide authorization, COGCC has indicated they can have these approved by Monday.
