Thanks for the email. As indicated during our phone conversation this morning, COGCC concurs with Vanguard to backfill the excavation. Confirmation samples suggested that any potentially impacted soil had been removed from the excavation (the only relevant parameter was a SAR value > 12 on one of the walls within the excavation).

On the other hand, after reviewing the table of analytical results attached to your email COGCC concluded that no impact occurred to the vegetated land down gradient of the pad.

Carlos,

We have received analytical results for all the soil and water samples collected to date. Preliminary tables explaining the sample results are attached. I have also attached the two figures that were submitted with the Supplemental Form 19, as these figures depict the sample IDs and where the samples were collected. Based on the analytical results, Vanguard requests permission to backfill the existing excavation at the release point and also COGCC's acknowledgement that no further sampling or analyses are needed from either the excavation or the spill path. If you concur with these requests, we will proceed with the preparation of an additional supplemental report for this incident and include all the attached data. In this report, we plan to request "closure" of this incident with no further remediation necessary. We would greatly appreciate an expedited response, so that we can schedule the backfilling activities as soon as possible.
