Operator Comment: GWOG and drilling contractor worked to isolate different equip to try & find low frequency source. Acoustic blankets were installed in front of the shale shaker and around drawworks blower on rig floor. Mobile acoustic walls were placed in front of shaker and on the prod battery near open area (with no sound walls). The mobile walls in front of shaker did not seem to help and may be moved to another location. Anecdotal evidence from south side of pad appear to indicate a reduction in low frequency noise. AG Wassenar was on site 6/29/17 to take readings and will compare those with baseline measurements before rig arrival. GWOG will submit sound survey results once available. GWOG emailed complainant Nate Morrison directly to see if he noticed difference after installation of mitigation equipment, but he has not responded back to date.
