Comment	Desirable plant species establishment is evident throughout most of the interim area. Vegetative gaps were observed along portions of the interim area. Vegetative growth throughout the interim area is not uniform but progressing towards a positive trajectory. Longspine sandbur ( <i>Cenchrus longispinus</i> ) was observed along portions of the interim area. May need to be control and manage Longspine sandbur if desirable plant species do not establish uniform growth. Please refer to the attached inspection photos for more details.
