The spacing unit is a 320-acre wellbore spacing unit for the Niobrara and Codell formations.

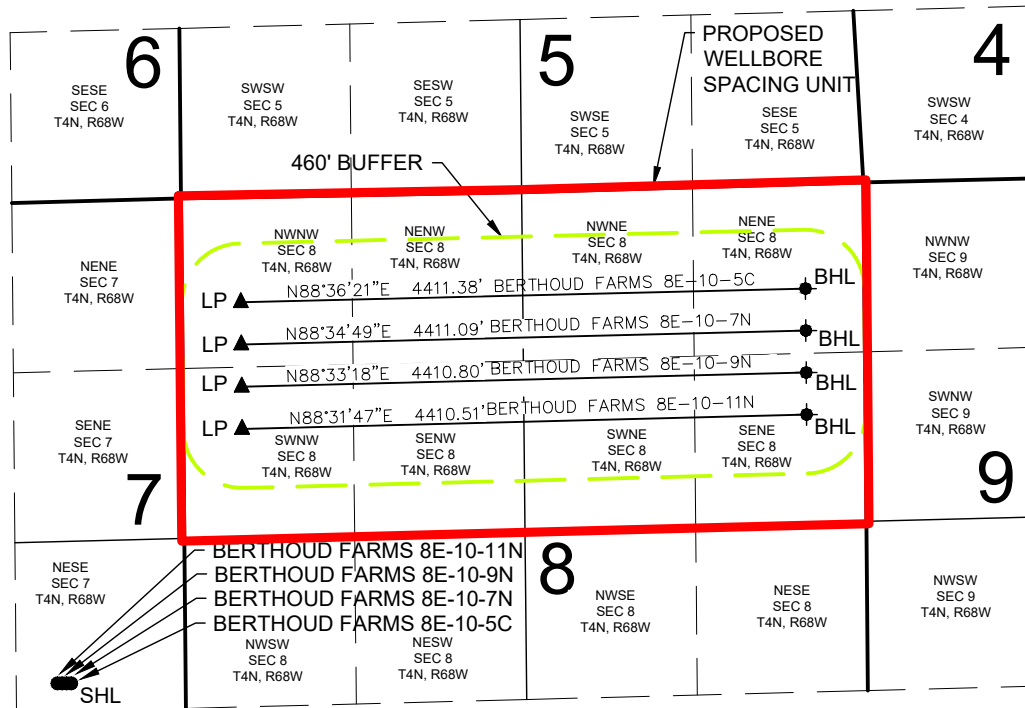
