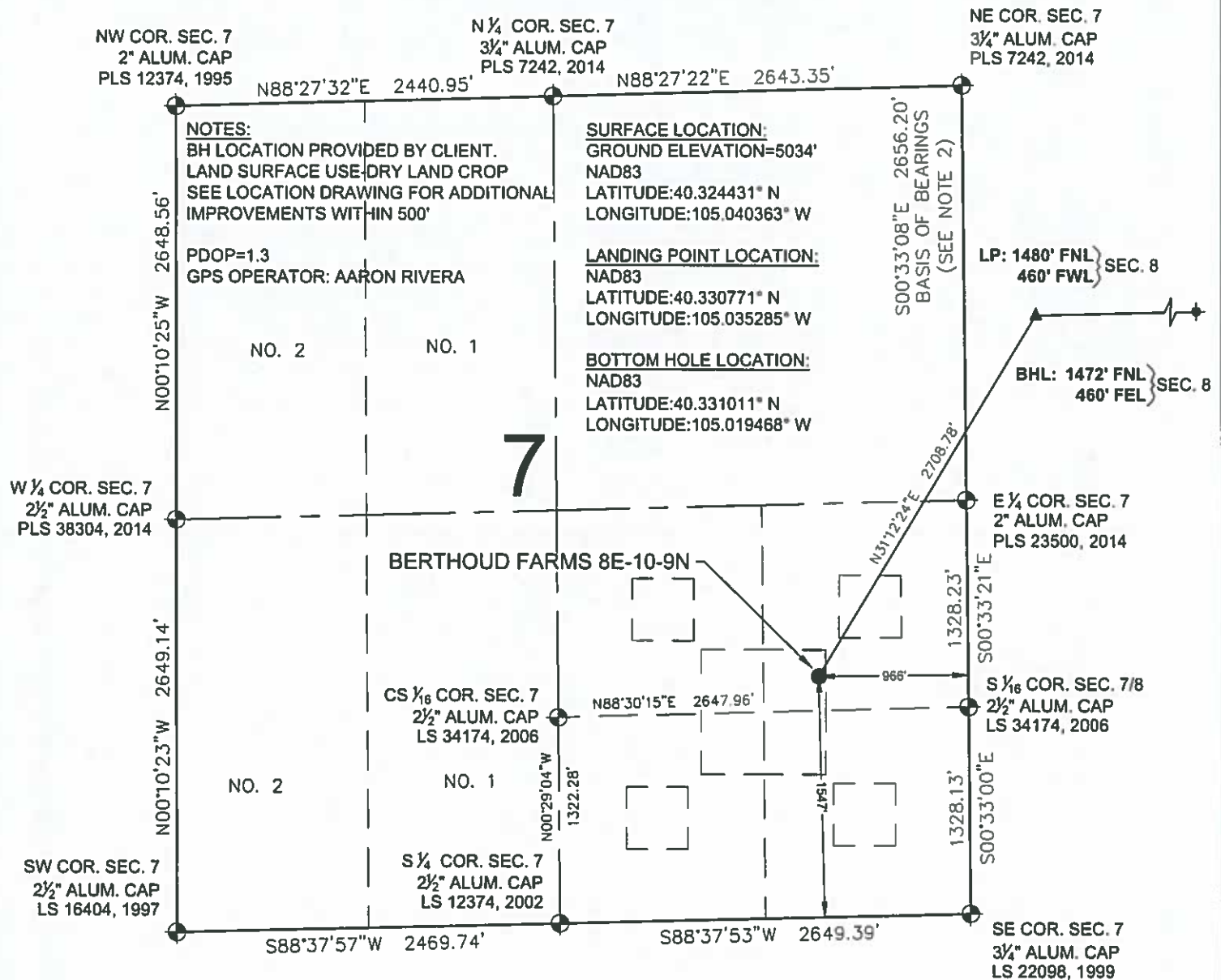


BERTHOUD FARMS 8E-10-9N WELL LOCATION CERTIFICATE

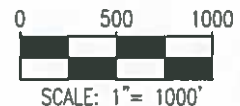

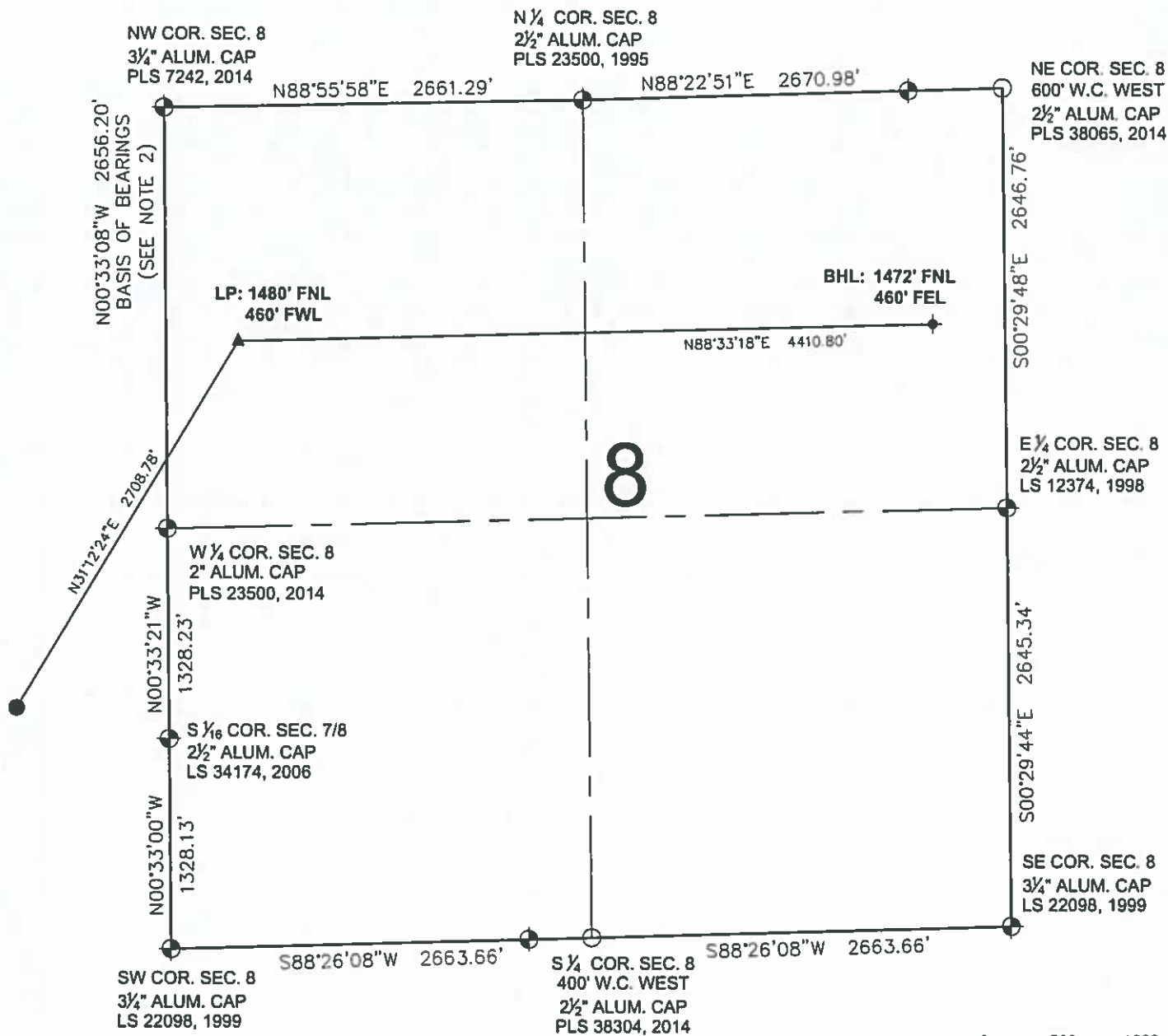
