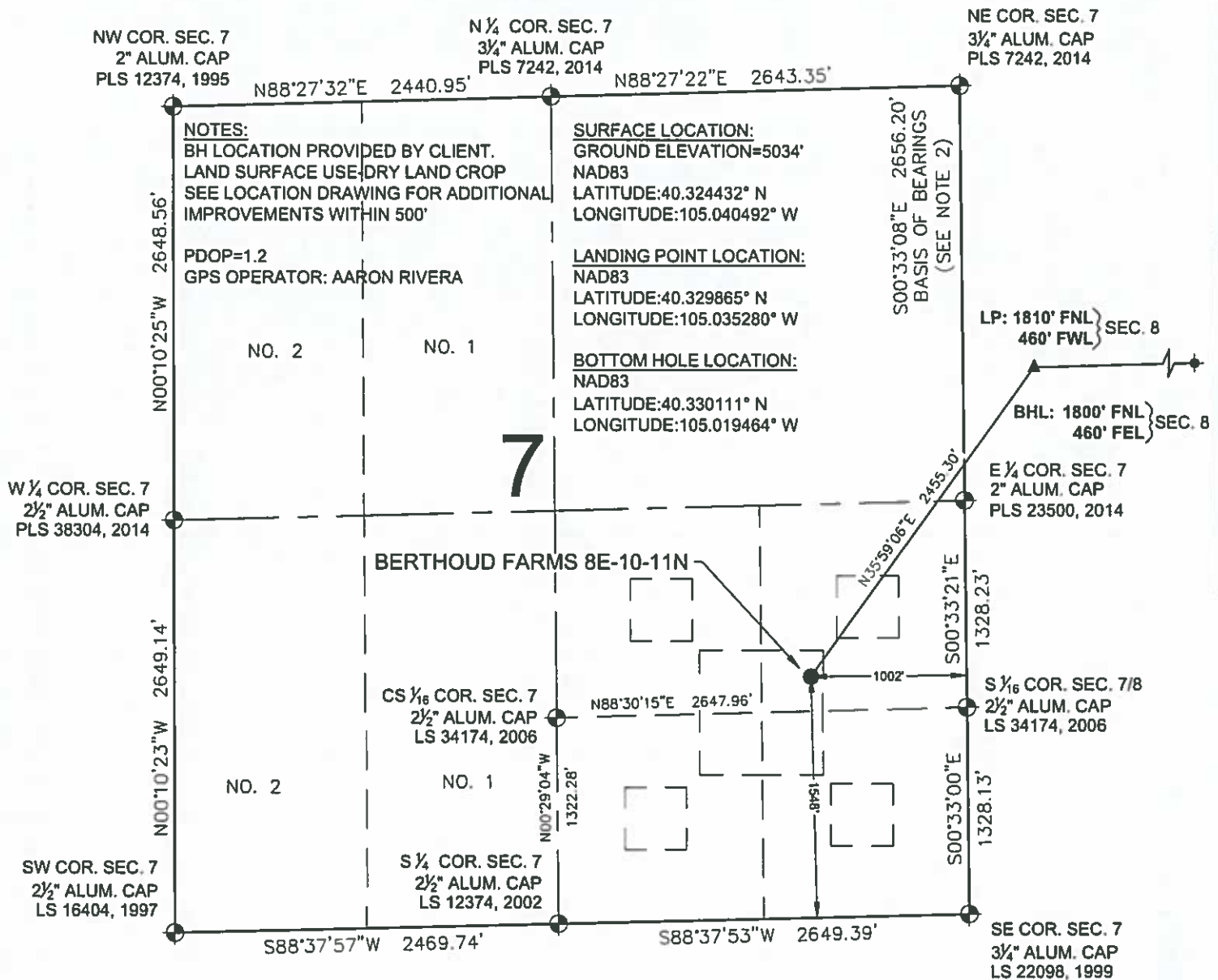


# BERTHOUD FARMS 8E-10-11N WELL LOCATION CERTIFICATE

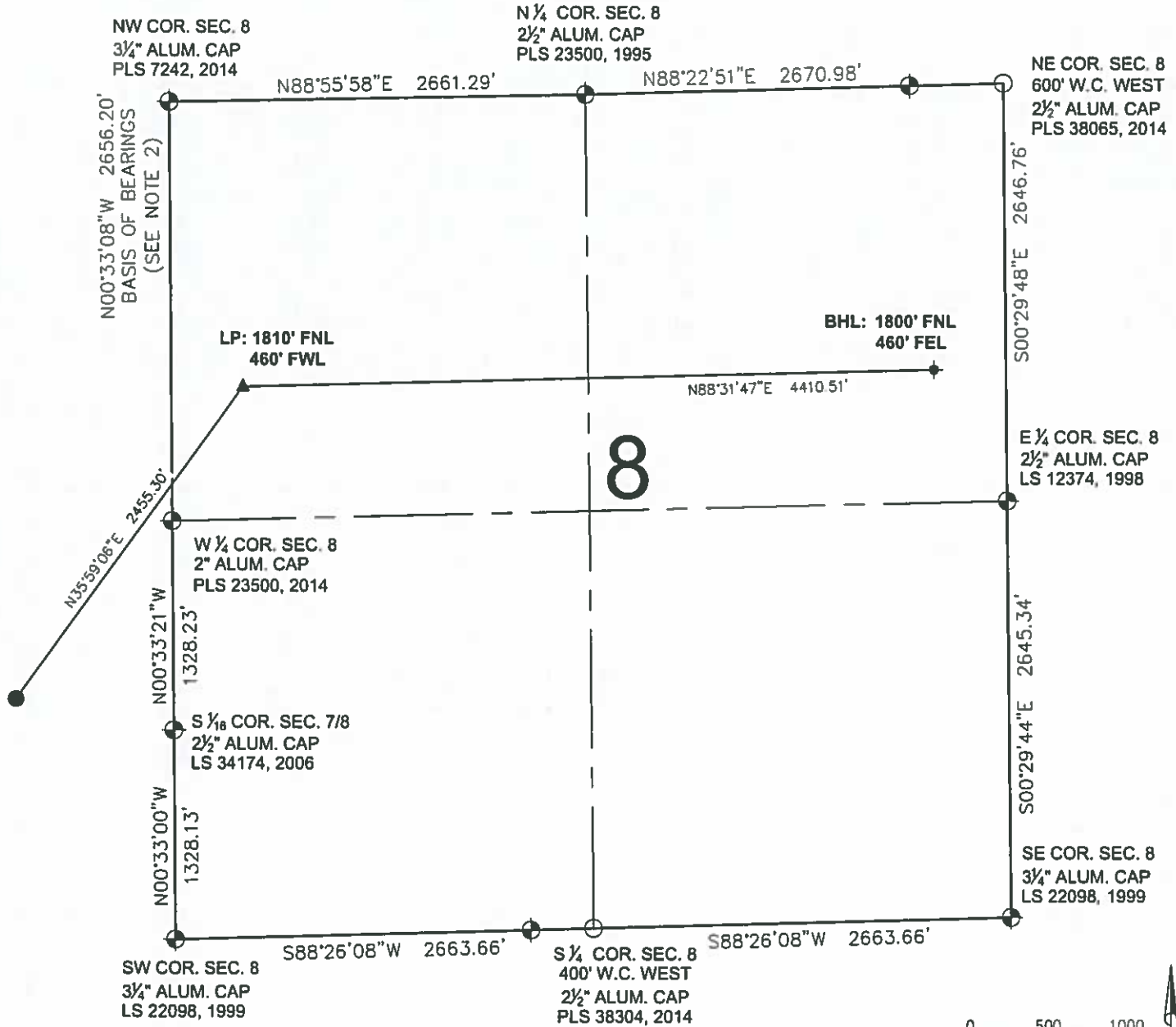
