Reclamation Rule 1004.a. requires all equipment to be removed and reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 5/23/2017. The well location and access road would not currently pass Rule 1004 standards at this time because stunted crop growth was observed; however, it is still within three months of plugging the location. One meter shed and equipment remains at the battery location. Please collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production but to also comply with Rule 1004 standards.
