Per the COGCC condition of approval (COA) issued on the approved Form 27, confirmation soil sampling was conducted to demonstrate that hydrocarbon impacts are no longer present within the unsaturated interval. Two confirmation soil samples were collected in the former locations of the excavation soil samples which exhibited constituent concentrations in exceedance of regulatory standards and are presently within the unsaturated interval. A summary of sampling activities and laboratory results is provided in the attached Form 27 Supplemental Letter. Based on the results of the confirmation soil sampling, PDC feels that no further site investigation is required.

As summarized in the attached Form 27 Supplemental Report and Request for No Further Action (NFA), enhanced fluid recovery (EFR) and air sparge (AS) activities were conducted on site between fourth quarter 2013 and third quarter 2016 to address remaining dissolved-phase petroleum hydrocarbon impacts on site. Monitored natural attenuation (MNA) was initiated during the fourth quarter 2016.

Groundwater monitoring was initiated at the site monitoring wells during the third quarter 2013. Samples were collected on a quarterly basis and analyzed for United States Environmental Protection Agency (USEPA) Method 8260B. During the third quarter 2017, four quarters of post-remediation constituent concentrations in compliance with COGCC Table 910-1 standards were achieved.
