Groundwater was encountered during excavation and drilling activities at approximately 15 feet below ground surface (bgs). PDC will continue quarterly groundwater sampling at the seven monitoring wells to monitor residual petroleum hydrocarbon impacts in groundwater using USEPA Method 8260. Groundwater monitoring will continue until four consecutive quarters of BTEX concentrations in compliance with COGCC Table 910-1 groundwater standards are achieved.
