COMMENTS:

We are requesting that in place of a MIT requiring a CIBP and pressuring up to hold at 300lbs we perform a witnessed Bradenhead Test. We believe this will be adequate as the downhole equipment is relatively new with very little pumping activity and the lack of corrosive zones in the wellbore. Additionally we would like to perform further pump tests and vent or flare the gas. This well has stranded gas at this time and we would like to test it and see if the gas cap blows down and and put the well into production or if the gas volumes stay high enough to warrant committing additional funds and efforts to secure a gas transmission line.
