<p>There are areas of the location and access road where soils are compacted and vegetation has not established. There is an electric powerline utility that goes to the location. There was trash debris such as tires and an old metal barrel at the location. Noxious weeds were noticed along the access road and location. The tank battery site near the highway has not been adequately reclaimed. There is gravel that remains and soils seem to be compacted. The vegetation has not established at this area. No other equipment or flowline riser were found. Corrective action date remains as previous inspection since corrective actions were not completed. <p>Corrective Action:</p>	<p>Comply with Rule 1004. Remove the powerline that runs from the location to the nearest point of usage. Remove any trash debris from the location and gravel from tank battery site. Decompect soils by cross ripping to a depth of 18 inches and reseed areas to establish vegetation.</p>
