Performed bradenhead test on 11 well pad post TD. Initial bradenhead pressure 700 psi had contiuous gas flow for duration of test, blew down to 500 psi. PDC is requesting a blowdown period and will plumb the bradenhead to a tank for 7 days monitor and re-test. A Bradenhead gas sample will be collected and will be submitted to COGCC as soon as results are available.
