#### COMMENTS:

Ward Petroleum requests to temporarily flare this well until October 1st to remove flowback fluid off of the formation and prevent possible well damage. Ward will utilize an enclosed combustor rated for 5 MMCFD to combust the gas and prevent venting. Ward will also ensure a green completion and flowback is utilized. Production equipment that is onsite will be used as it is ready to eliminate any other possible emission sources and waste. An H2S sample will be taken to ensure there is no H2S associated with the gas, that analysis will be submitted on another sundry. Currently pipeline is onsite and is ready to take gas flow, but the gas plant is not in operation. The gas plant is planned to come online in mid to late September if all goes well. If the plant is ready to process gas sooner, flaring will end onsite. Ward will make every attempt to sell gas as soon as possible.
