S½S½ of Section 8, Township 7 North, Range 66 West

Bayswater is not the only owner within the Proposed Spacing Unit and has provided notice to the remaining owners, as required by COGCC Rule 318A.e.(6). 

SEC 8: S2S2**




**BOOTH U-8-7HN WELL TO BE LOCATED 1261' FSL AND 248' FEL, SEC 8, T6N, R66W
