Comment: Two points of discharge were observed along a portion of the access road and along the southeastern well location. Rill erosion observed along the western cut slope of the location which is contributing to sediment discharge off location. Rill/gully erosion observed throughout the central well location which is traveling to the southeastern location. Gully erosion observed at the southeast well location which is causing sediment discharge off location. Operator may need to install some form of a stabilized outlet (i.e., sediment trap) to control and manage stormwater to prevent sediment discharge off location. Please refer to the attached inspection photos for more details.

Corrective Action: Install or repair required BMPs per Rule 1002.f. Operator needs to control and manage the two points of discharge, repair/control rill erosion occurring along the western cut slope, and repair/control rill and gully erosion throughout the well location.
