Tubing: 2 3/8" tubing set @ 6738' (4/21/2015)

Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6698'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set BP at 6459'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with tubing to 600'. RU cementing company. Mix and pump 50 sxs 15.8#/gal CI G cement down tubing. Cement circulate to surface.
6. Cut surface casing 6' below ground level and weld on cap.
