Comment: The t-post and wire have been removed since the previous inspection. The desirable vegetation establishment appears to have increased since the previous inspection but has not reached 80% cover of the reference area. There is an area approximately 120'x50' with predominately undesirable weeds (Kochia sp.). Additional seeding and weed control in this area will facilitate desirable vegetation establishment.
