Perform reclamation on in accordance to COGCC 1000 series reclamation requirements/standards and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels at the well and tank battery locations. To allow time to collaborate with the surface owner to determine a seed mix as well as mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production, revegetation activities shall completed no later than September 15th, 2017
