Abigail,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

1) In the Cultural Setback Distance section Bison has indicated the nearest Public Road to a well is 3,814 feet and to a production facility is 3,539 feet. During my review it appears that Weld County Road 105 is approximately 1,300 feet to the east of your proposed Oil & Gas Location. Please provide me with the distance to WCR 105 from the nearest well and nearest production facility and I will revise the Cultural Setback Distance section.

2) In the Water Resources section Bison has indicated the nearest water well is 4,425 feet. This appears to be the distance to the water well that the estimated depth to groundwater was based on. During my review it appears there is another water well that is closer to your proposed Oil & Gas Location. Water well permit #200306 appears to be approximately 3,000 feet to the north. Please provide me with the distance to water well permit #200306 and I will revise the Water Resources section.

3) The Location Drawing has a note indicating there are no existing improvements within 500 feet of the proposed disturbance. However, the Access Road Map depicts an existing fence that runs along the boundary between Section 27 and Section 22 to the north. This fence appears to be easily within 500 feet of the proposed disturbance. If this is true, please send me a revised Location Drawing showing this existing fence and its distance and bearing from your reference point well. If there is no existing fence, please send me a revised Access Road Map with it removed.

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

1) In the Cultural Setback Distance section Bison has indicated the nearest Public Road to a well is 3,814 feet and to a production facility is 3,539 feet. During my review it appears that Weld County Road 105 is approximately 1,300 feet to the east of your proposed Oil & Gas Location. Please provide me with the distance to WCR 105 from the nearest well and nearest production facility and I will revise the Cultural Setback Distance section. **Distance to Public Road from nearest well: 1295'**  
**Distance to Public Road from production: 1220'**

2) In the Water Resources section Bison has indicated the nearest water well is 4,425 feet. This appears to be the distance to the water well that the estimated depth to groundwater was based on. During my review it appears there is another water well that is closer to your proposed Oil & Gas Location. Water well permit #200306 appears to be approximately 3,000 feet to the north. Please provide me with the distance to water well permit #200306 and I will revise the Water Resources section. **Correct distance to nearest water well is 2,742'.**

3) The Location Drawing has a note indicating there are no existing improvements within 500 feet of the proposed disturbance. However, the Access Road Map depicts an existing fence that runs along the boundary between Section 27 and Section 22 to the north. This fence appears to be easily within 500 feet of the proposed disturbance. If this is true, please send me a revised Location Drawing showing this existing fence and its distance and bearing from your reference point well. If there is no existing fence, please send me a revised Access Road Map with it removed. [Please replace current Location Drawing with the attached.](#)
