General Comment:

August 15, 2017, COGCC staff Kris Neidel inspected the State 1-36 location to assess a spill that was reported to the COGCC by Jackson County Staff. A path of scraped soil: from wellhead down ~275; along county rd 26B, it appears to not have impacted the county rd or any culverts, ditches, etc. There were intermittent traces of hydrocarbon remaining. Soil that was scraped is being stored on the northwest corner of the pad. It appears that some soil has been removed from a cut portion of the pad, the pad should not be enlarged without completion of a Form 2a site assessment. The production pit on location had 100% oil coverage; Markus staff was notified that by rule oil should be removed within 24 hours of discovery (rule 902.c). please contact COGCC staff, Kris Neidel, 72hrs prior to collection of soil samples to confirm clean up. Per Inspection from 11/18/2010, "PROPERLY PERMIT PIT (PER RULE 903) OR CLOSE PIT PER RULE 905." Please submit a Form 27 Remediation workplan for pit closure by 9/21/2017. Please work with surface owner, BLM and COGCC reclamation staff on reclaiming the surface of the impacted area.
