1) After reviewing the Inspection report doc #689100044 that I submitted on 8/28/2017, I noticed that I switched mg/kg and mg/L in the following paragraph:

*"Sampling events were conducted in 2013 and 2014 and reported to the COGCC. Analytical results indicated that all hydrocarbon parameters analyzed (TPH and BTEX) were well below COGCC Table 910-1 values. A max DRO value was measured in spring 2014 (DRO=4.5 mg/kg). COGCC max value for TPH (DRO+GRO) is 500 mg/L."*

It should have said: DRO=4.5 mg/L, and 500 mg/Kg.

2) There are no reported soil analytical results on COGCC database (other than a background sample). It appears that at some point in time HRL took soil samples for Source Gas on the depression northeast of the pad. At least one sample had a TPH value above Table 910-1 (above 500 mg/Kg).

Forest Service and/or BLM has/have requested a new round of soil samples. COGCC requests that Blackhills submits the analytical results to COGCC via Sundry Notice (e-form 04), to follow-up on that detected impact.
