The following shall be performed by 7/31/17: Remove the meter shed equipment, remove gravel from location and access road, perform compaction alleviation, re-contour/re-grade access road, and manage noxious weeds. Ensure temporary stabilization controls are in place until revegetation activities can occur later in the Fall. See COGCC comments for additional corrective actions regarding revegetation.

Operator Comment: Margret Ash (COGCC) to discuss specific issues related to circumstances outlined in a 2014 email correspondence with this landowner. Margret advised BBC to proceed with a factual review request, even though our meeting with her was past the 7-day FIR submitted date.

COGCC Decision: Approved pending re-inspection

COGCC Representative: This location does not comply with COGCC's final reclamation rules and several corrective actions listed on Field Inspection Report # 682402371 have not been completed. However, because of extenuating circumstances BBC is not able to access the site due to threats of lawsuits and other harassment.

On July 17, 2017, DCP removed the meter shed per the last CA inspection (Doc. 682402371). The meter shed has been removed as required; however, the remainder of the final reclamation, re-contouring, weed control and revegetation, has not been conducted. Given the current access issues, this site will be given an "In-Process" status for reclamation for the unforeseeable future. A final passing reclamation inspection is still required for the final bond release on this location and if a future surface owner complaint about final reclamation status is submitted, it may require BBC to finalize reclamation work at this location.
