Inspection Observations:
An inspection of the above location was conducted with a focus on odor, from 1100-1200hr. Winds were from the north, and north-northeast at a variable speed, from 0-3 mph. Odor was detected intermittently offsite. Jason Oates of Crestone was offsite at the location and detected the intermittent odor. Third party detection was being performed at the time off site. Erie Police Department had responded to submitted complaints for the morning, under the following case numbers: 17-1990 and 17-1991.

Corrective Action: Odor observed by COGCC staff related to referenced oil and gas location, actions must be taken to stop the odor per Rule 805.b. Additionally, this matter has been referred to the CDPHE for possible further investigation.
