Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 7124'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set BP at 6736'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with casing cutter. Cut 4 1/2" casing at 650'. Pull cut casing.
6. TIH with tubing to 700'. RU cementing company. Mix and pump 210 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
