Crescent Point Energy U.S. Corp respectfully submits the final abandonment notice for the Slick Rock Fed 8-23-4-17. The pad was initially seeded on October 29, 2010 by predecessor operator Rover Resources, Inc. then reseeded December 2, 2015 by Crescent Point Energy U.S. Corp with intermittent weed treatment efforts beginning 2012. Crescent Point Energy U.S. Corp and the BLM have agreed that the site is eligible for final abandonment and bond release with the access being left intact as previously requested by the adjacent landowner and agreed to by the BLM.
