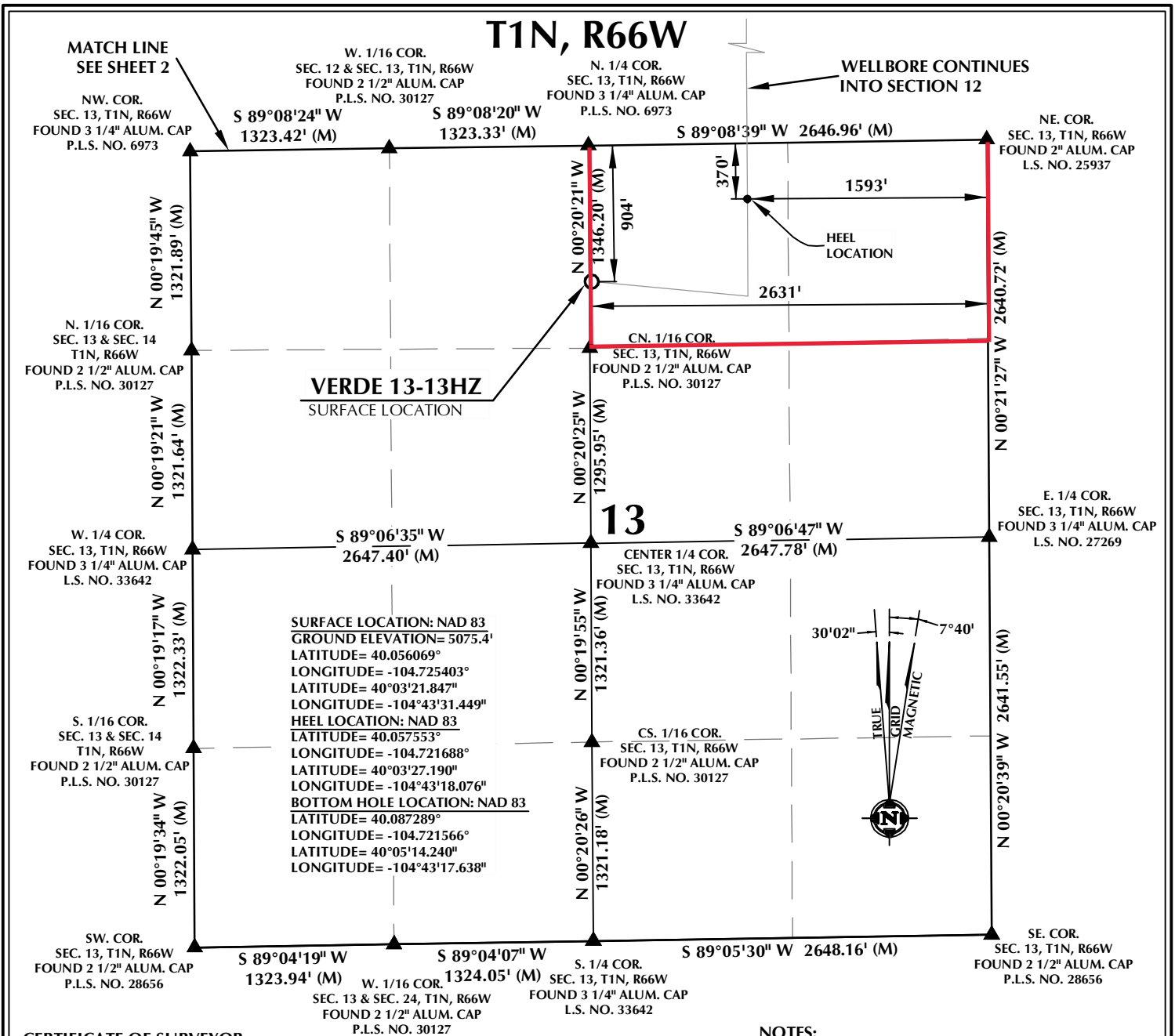

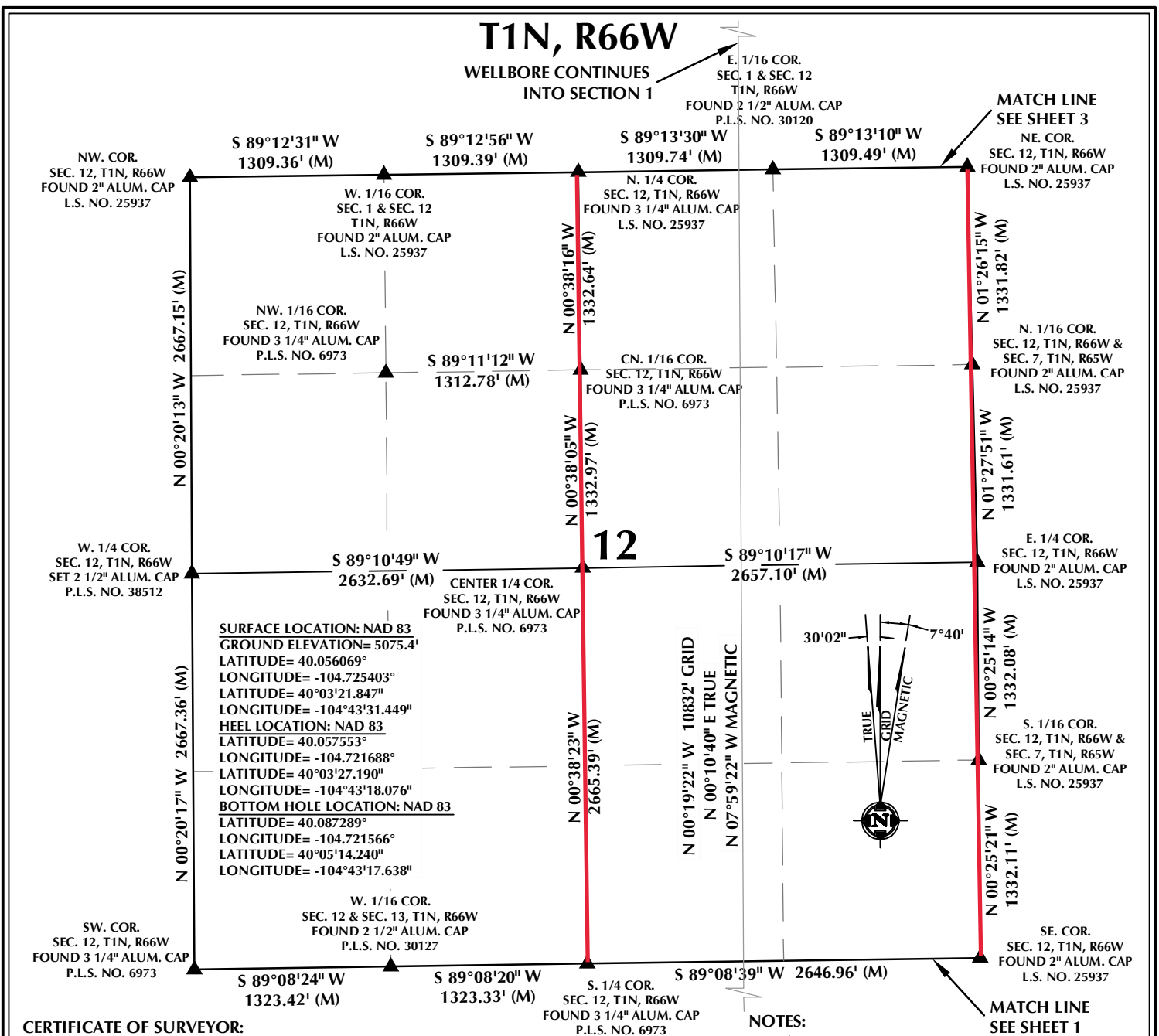

PROPOSED SPACING UNIT



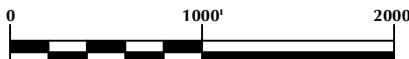
