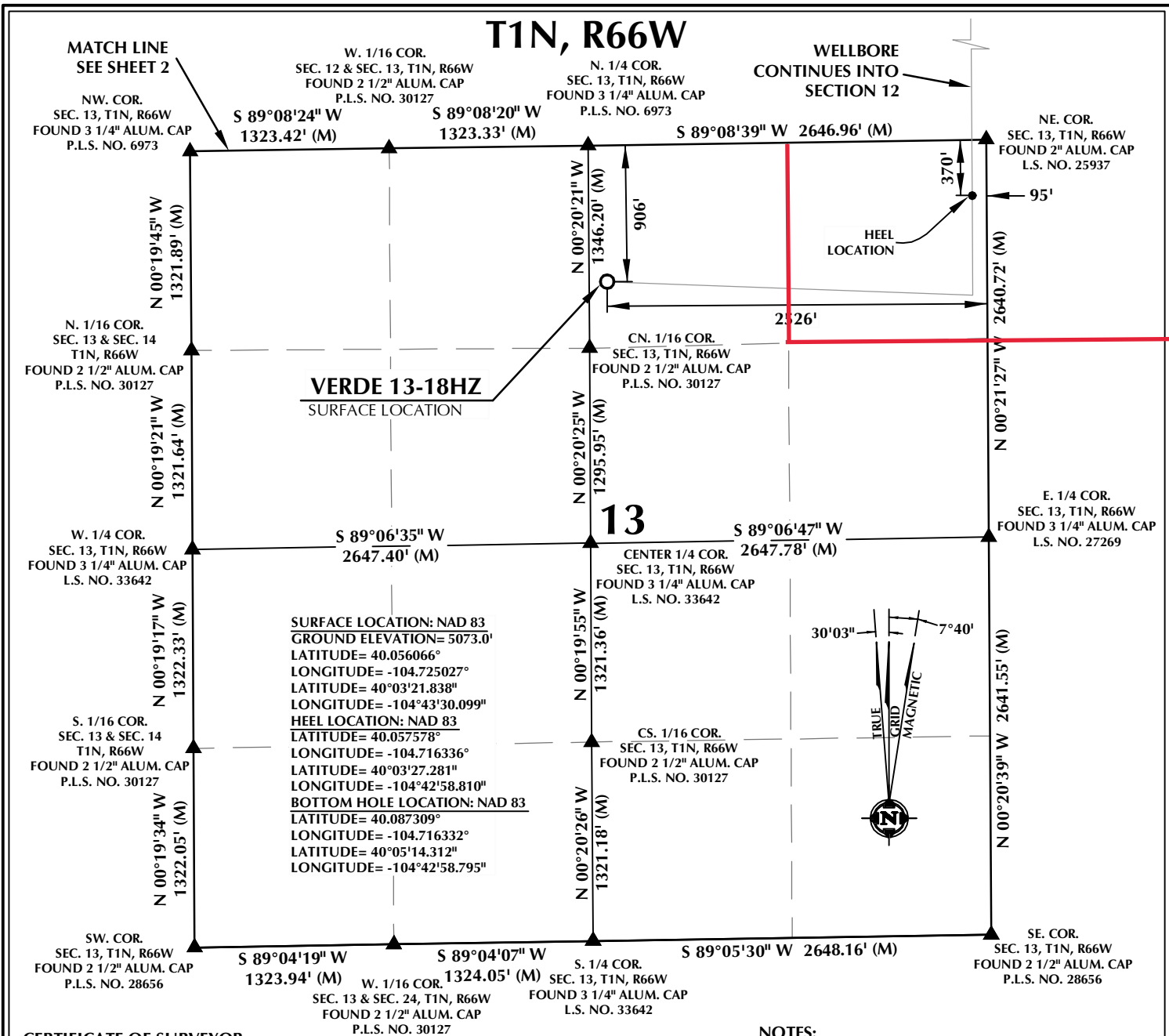

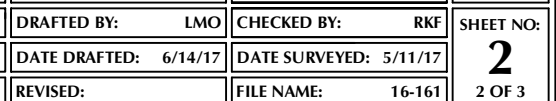

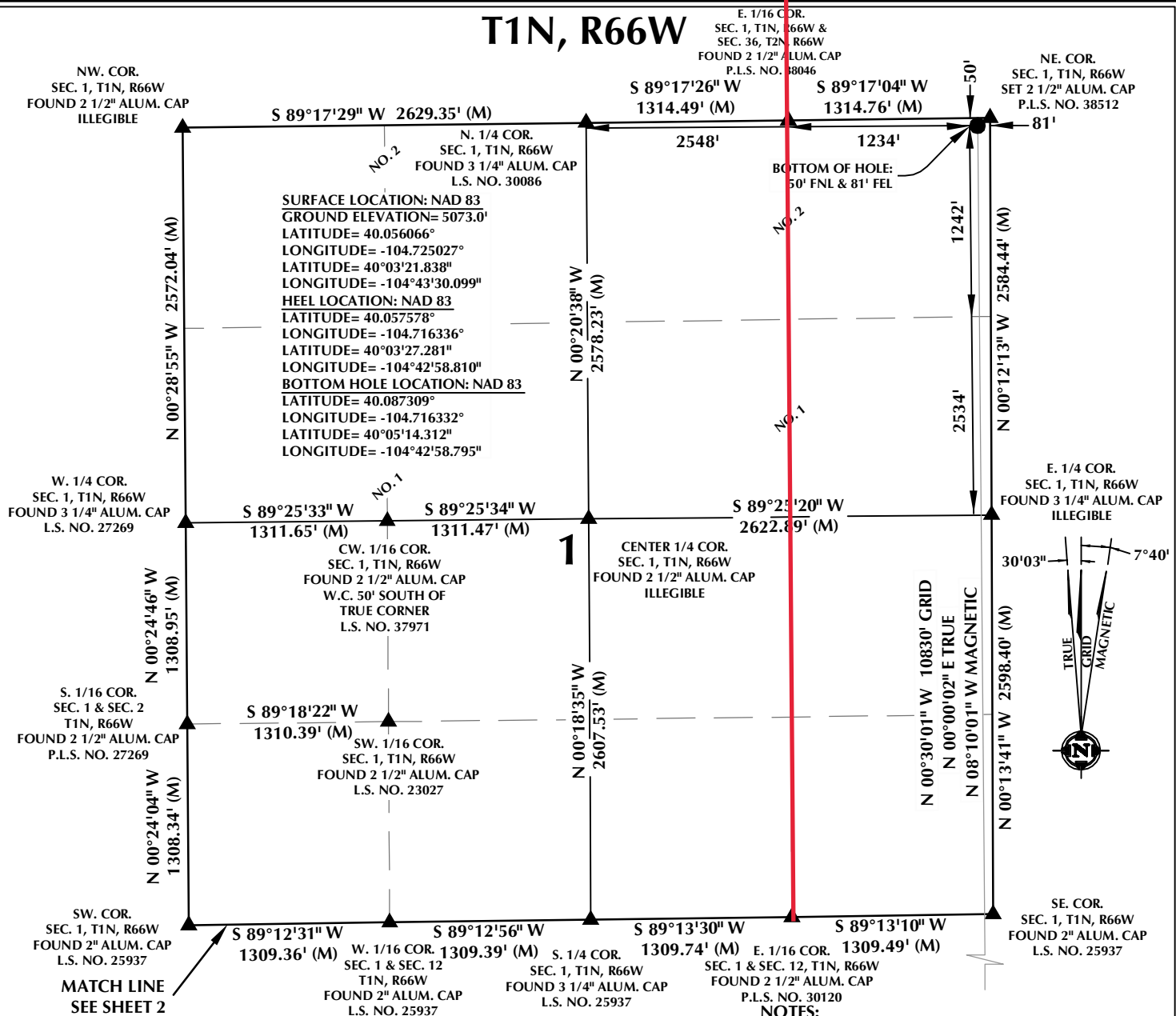

PROPOSED SPACING UNIT



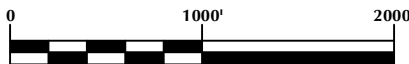
