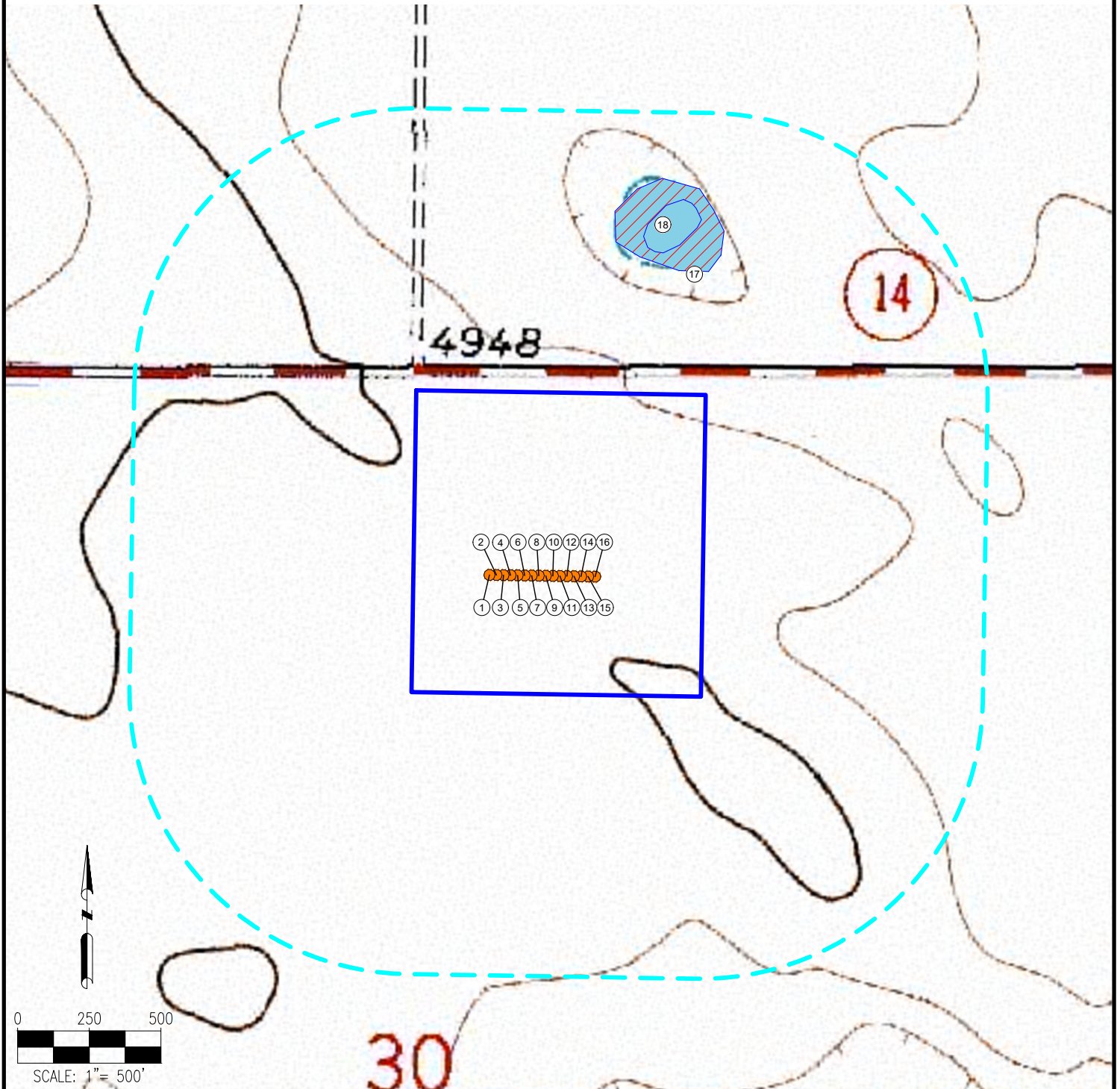


GADWALL PAD HYDROLOGY MAP
