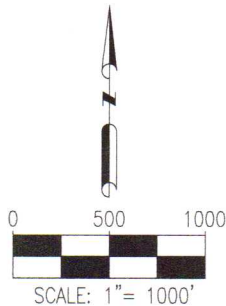

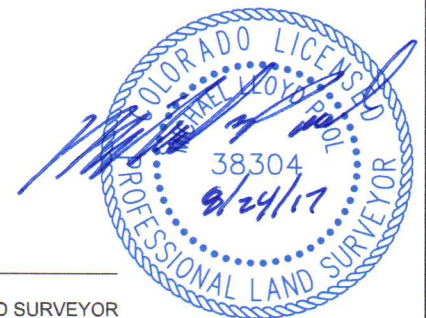
GADWALL 30-31-8HN WELL LOCATION CERTIFICATE
