Hello, Mike

This is in response to Murfin's 8/9/17 Rule 305 and 306 letter to Andy Gaede ("Letter"). I am authorized to act on Andy's behalf regarding this response to the Letter.

Please accept this email in satisfaction of the consent return requested in the Letter.

Firstly, thank you for your, Mike Rusco's, and Bernie Meyer's time and attentiveness.

Secondly, as the subject consultation has occurred, Andy waives a request for consultation (except with respect to the final road location discussed below), as well as the 30-day notice for drilling. Notwithstanding the drilling notice waiver, please do keep Andy advised of the status of your operations, particularly the start of operations.

We do expect strict compliance with the COGCC rules and the applicable Surface Use Agreement (as amended). Please also note the Surface Use Agreement you sent was incomplete. Attachment A was missing from what you sent. To be sure we all remain on the same page, I'd like to ask that you please send me your Attachment A (presuming you have one), and if you don't have an Attachment A, let me know, and I'll send you what I have, and then we can confirm the completeness of the amendment.

In terms of locations, I believe your team has confirmed the drilling site (as now staked) with Andy and the general location of the road, which will run generally north-south from the County Road to the site. We do request one additional meeting to confirm the final road location. Your team should coordinate this with Andy, directly. Any changes to these locations should be confirmed with Andy in advance and in writing. No part of this email should be construed as consent to any alternate locations.

Finally, all ongoing communications regarding this project should be directed to Andy – he does not designate a representative/agent. I believe you have his contact information, but let me know if you need it or anything else.
