Soil samples were collected during excavation and site investigation activities. Impacted soil has been removed via excavation through lab confirmation soil sampling and analysis of TPH-DRO, TPH-GRO, BTEX, and Naphthalene using EPA Methods 8015 and 8260.

### Proposed Groundwater Sampling

A total of 30 groundwater monitoring wells were installed and sampled in 2013. All samples were collected and analyzed for BTEX by EPA Method 8260. Currently MW6, 7, 13, 14, 16, 17, 18, 22, 23, 25, 25, 26, and 28 are in the monitoring program.

A combination of calcium peroxide and granulated activated carbon was injected into the subsurface in a grid pattern at various depths to help mitigate dissolved BTEX impacts. Post injection, quarterly groundwater monitoring has been scheduled to monitor natural attenuation and ensure the dissolved groundwater impacts are stable and decreasing.
