There will be a buried 3" steel line from each wellhead to each separator and heater treater. Then there will be three 3" steel surface lines from each heater treater to the tanks. There will be a 4" surface line from the tanks to each combustor and a 2" buried steel line from each separator to the flare. Surface lines to the tanks will be heat traced.

Longs Peak is currently working on plans and in negotiations with pipeline companies to be able to gather and process the wellhead gas and then be able to sell the residue gas into nearby transmission lines.
