## COMMENTS:

During construction of the Nichols 24-6a (450791) and Nichols 24-7 (450760) pads, the fill slpe of the 24-7 begin slipping toward the cut slope of the 24-6A. Once the cut slope began loading up on the 24-6A, Laramie began to notice some cracking and slipping cut slope. Laramie ceased operations and began a geotechnical investigation of the issue and is submitting the results of the site analysis as well as engineered and stamped plans for stabilizng the two pads for contiued use and operations.
