Comment: Debris has been removed and some desirable vegetation is struggling to establish. Noxious Weed, Canada Thistle is established on North Perimeter of Location; Kochia (which will become Debris) is scattered across Site, especially heavy growth around Riser. Abandoned gathering line risers, flowline risers have not been removed within three months of plugging (2/1/2010) the associated Facility. It is advised to Monitor site for Vegetation progress and success of Weed Control efforts.

Corrective Action:	CA#1) Comply with the 1004 Reclamation Rules to remove abandoned gathering line risers, flowline risers, and equipment within three months of plugging the associated facility; revegetating areas disturbed by removal activities. Refer to Photo log attached for Pictures & GPS Positions of Risers. CA#2) Control Noxious Weeds & Weeds that will become Debris. CA Dates remains at Date from Previous Insp: 6/1/2016.	Date	06/01/2016
