Comment: MIRU IPS wireline, RIH with 4 1/2" 10K CIBP and set @ 6870' KB, POOH with setting tool, RIH with dump bailer and spot 2 sxs of cement on top of CIBP, load and pressure test csg with rig pump to 950# for 10 minutes with no leak off, release pressure, RIH and perforate csg @ 2500' KB 4 SPF, POOH with spent gun, RDMO wireline, establish injection rate with rig pump, MIRU Holeseekers hydrotester, TIH with CICR hydrotesting and set @ 2415' KB for annular squeeze, RDMO hydrotester, MIRU Leed Energy Services cementers, pump 10 bbls of mudflush followed by 5 bbls fresh water spacer, mix and pump 195 sxs Plug Cem 15.8 ppg cement slurry (40.7 bbls total) through CICR, displace tbg with 7.2 bbls of fresh water, sting out of CICR and spot 10 sxs of cement slurry (2 bbls total) on top of CICR , RDMO cementers, POOH with tbg and stinger, SIW, SDFN.
