Please see the attached wellbore diagram and procedure. Note that there is a suspected casing patch at 3,030' in the 4-1/2" casing and suspected perforations in the Codell (from a previous operator). These items are not listed on the state website. The presence or lack of these items will first be verified via a CCL and pressure test. Proper subsequent reports will be submitted based off what we find. A deep plug will be set above the top of the Niobrara to isolate for the Johnsons Corner horizontal fracs by Extraction. A shallow squeeze job will be performed in the 4-1/2" at 475' with cement circulated to surface. A bond log will be ran to verify cement coverage.
