I have returned this document (401402171) to draft because the arsenic level of the stockpiled material is in exceedance of Table 910-1 standards and the background level is below detection limits.

BP will either need to collect additional background samples to be analyzed for arsenic, or defend their closure request with Table 910-1 exceedances.
